# Prestwich Village Neighbourhood Plan Local Open Space Assessment

March 2025

Prestwich Environmental Forum (PEF) have completed a survey of open spaces within the Neighbourhood Plan boundary area. As a local community group, PEF has worked with its members and local stakeholders to identify the sites. As a volunteer organisation the survey is not exhaustive and relies on the local knowledge of volunteers in both PEF and other environmentally minded local groups, supplemented by use of mapping tools such as Google Maps and What3Words.

All identified spaces were assessed to identify properties of significant beauty, historic significance, recreational value, tranquillity or wildlife properties. These sites have been proposed for designation as Local Green Space (LGS). These sites are presented in Section 1 below.

Working on the basis that all green and open spaces offer benefits to the community by way of supporting biodiversity, air quality and a sense of space, the remaining sites are proposed as Sites of Community Amenity (SCA). These sites are presented in Section 2 below.

For all sites, PEF has considered both the current benefits the space provides and where improvement opportunities can be considered. PEF has only provided an overview of the basic and generic principles for sites such as these. For any improvements to be undertaken, PEF believes it is crucial that there is first engagement with residents & stakeholders who have the best understanding of the space and may already be maintaining or improving a site. As such, in almost all cases, PEF has recommended that a potential improvement opportunity includes facilitating community ownership so that local residents, businesses and others can actively be engaged in considering, planning and, where applicable, supporting any proposed developments.
